Article 5. The regular members may leave the Service by written notice.

Article 6. The funds for the work of the Service shall be contributed by the Association of China Reconstruction Service and the members of the Sino-American Economic Service.

Article 7. The regular members shall contribute a monthly sum of C.N.C.\$40,000. The Supervisory Board shall have the power to increase or reduce this amount or exempt payment as they see fit. Those who are exempted from payment shall have no financial responsibility to the Service.

Article 8. The regular members shall have the preferred privilege of securing services.

Article 9. A Supervisory Board shall be established, the president of the Association of China Reconstruction Service being concurrently the President of the Board and representatives from the regular members being the members. They will elect among themselves three to nine members to form a Standing Committee.

Article 10. The Supervisory Board shall meet quarterly, and if necessary a meeting may be called for at any time.

Article 11. The Supervisory Board shall be responsible for:

1.—Deciding policy of the Service.

2.—Examining work reports by the Service.

3.—Approving applicants as regular members of the Service.

4.—Safe-keeping of the funds of the Service.

5.—Examining and auditing the accounts.

6.—Appointing and discharging the Director and Associate Directors of the Service.

7.—Deciding other important matters.

Article 12. A Director and two Associate Directors shall be recommended by the Supervisory Board and staff members by the Director and are engaged by the Supervisory Board.

Article 13. The Service shall have the following departments:

1.—Information Department.

2.—Research Department.

3.—Agency Department.

Article 14. The Service may invite honorary advisors and members of planning board.

Article 15. The Service may establish different kinds of technical committees.

Article 16. The accounts of the Service are independent.

Article 17. The regulations for the service funds are fixed up separately.

Article 18. In order to maintain the routine works of the Service a fee may be charged as follows:

A. Under Group I of Article 2

1.—No payment by the regular members.

2.—Non-members shall pay actual labour, printing, mail and telegraphic costs.

B. Under Group II of Article 2:

Charges shall be levied for services being given to the regular and non-members.

Article 19. Changes of the constitution may be proposed by the Supervisory Board and approved by the Association of China Reconstruction Service.

THE SINO-AMERICAN ECONOMIC SERVICE

PREAMBLE

After the Allied victory over the Axis Powers, naturally we must turn our attention to the maintenance of peace which depends entirely upon the relations between the United States and other countries. Particularly, the relationship between the United States and China will be more intimate especially in its economic aspects. In the immediate future we can consider the question of how to readjust and rehabilitate the economic relations with America to be the most important. From the point of view of both these countries we must find a way to utilise the immense man power as well as financial, technical, to develop agriculture, mines etc. for the peace and prosperity of our two countries. For these developments it will depend upon the combined efforts and cooperation of our two peoples. For the past eight years, owing to the total war, the economic relations between the two countries were severed to a large extent. So that each has lost contact with the other with regard to the improvements in agricultural production, industrial developments and the improvements in the means of communications. Furthermore, the lack of currency stabilization in China and the fact that the Chinese Commercial Law governing the foreign firms doing business in China has not been promulgated tend to make foreign business men adopt a "wait and see" attitude. All these and other conditions existing between the two countries are not conducive to the development of trade and economic relations.

All of these obstacles which hinder the early resumption of trade and economic relations between America and China are for the governments of the two countries to remove to a large extent. But as private citizens and associations we can do a great deal to help where government cannot function so freely.

The Association of China Reeconstruction Service aims at the building up of a New China and is prepared to render service to those who take part in the tremendous work of reconstruction. Hence, the Association sponsers the Sino-American Economic Service with the hope that those interested in the promotion of peace and prosperity between the two countries will take an active part in this Service.

Article 1. The Association of China Reconstruction Service with a view to develop Sino-American trade and economic relations shall establish the main office of the Sino-American Economic Service in Shanghai. When the need arises branch offices shall be established at Tientsin, Hankow, Canton. Chungking, Dairen, New York, Chicago, San Francisco etc.

Article 2. The following services will be undertaken by the office:

Group I:

1.—To provide general Sino-American economic information;

2.—To provide particular financial news;

To provide a clearing house for the Sino-American technical knowledge as well as to establish an employment bureau for technical men;

4.—To study Sino-American imports and exports;
5.—To plan the establishment and development of Sino-American agricultural, industrial, commercial and mineral enterprises:

6.—To make researches into Sino-American agricultural, industrial. commercial and mineral organizations and enterprises:

7.—To study into kinds, quantities and producing technique of Sino-American reciprocal selling products:

8.—To investigate Sino-American Reciprocal selling markets:

9.—To distribute samples and enlarge the publicity for Sino-American reciprocal selling products;

10.—To provide convenience to travellers, guiding and interpreting service to Sino-American economic business transactions:

11.—To accept commission works regarding Sino-American affairs.

- 1. To recommend Sino-American investments and credits;
- 2.—To push the sales of Sino-American selling products;
- 3.—To accept the appointment as purchasing agents for Sino-American agricultural, industrial, commercial and mineral organizations and other enterprising organizations:

4.—To act as agents for Sino-American trading companies.

Association of China Requisition Service.

Article 3. The Sino-American agricultural, industrial, commercial and mineral institutions and organizations who agree to our principles may be members of our Service after being approved by the Supervisory Board.

Article 4. They may not be regular members when they do not fulfil duties of the regulations.
